PROGRAM CRITERIA

I. RECREATION GRANT PROGRAMS:

- WILL PROVIDE RECREATION/LEISURE ACTIVITIES FOR THE BENEFIT OF THE YOUTH OF GRAND FORKS
- ARE INNOVATIVE AND CREATIVE
- IF POSSIBLE, TO BE MATCHED DOLLAR FOR DOLLAR BUT NOT A REQUIREMENT
- LIMITED TO \$500.00 PER APPLICATION (ORGANIZATION)

II. SPORT GRANT CRITERIA:

- FUND MUST BE USED FOR FACILITY SUPPORT.
- MUST BE NON-PROFIT ORGANIZATION.

GRANTS, GENERALLY, MAY NOT BE USED FOR THE FOLLOWING:

1. Activities restricted to a group's membership
2. Projects from schools or religious institutions which ignore non-members or non-Students.
3. Projects already completed at the time of application
4. Travel costs

Funded projects will require an accurate financial report and documentation (i.e. copies of invoices, statements) of expenses and final project summary upon completion.

Acknowledgment of the "Grand Forks Park & Recreation Foundation Grants Program" is required on all projects receiving funds.

Application must be printed or typed on the form provided.
